MEMBERSHIP NOMINATION PROCESS

Requisites for Membership: A member must be an adult person of good character and good business and professional reputation, who

- (i) engages as a proprietor, partner, corporate officer or manager of any worthy and recognized business or profession;
 - (ii) holds an important position in any worthy and recognized business or profession or any branch or agency thereof, and has executive capacity with discretionary authority; or
 - (iii) is distinguished in community, civic or political activities; or
 - (iv) has the status of Rotary Foundation alumni - Ambassadorial Scholar, World Peace Fellow.
- 1) Club member(s) identify a prospective member and submit a Membership Nomination Form to the club office to be reviewed by the Membership/Classification Committee which meets once per month.
 - 2) New member names are submitted for review by the board of directors at their monthly meeting.
 - 3) Board approved proposed member names are posted in the weekly newsletter for one week for existing members to voice any issues.
 - 4) Proposed members are required to attend a one hour Rotary Information meeting where club history and expectations of membership are discussed.
 - Monetary – one time \$150 initial; fee regular bi-annual dues of \$243.50. This includes a temporary \$30 assessment for the Centennial Project.
 - Participation – attend weekly luncheons which are held on Thursdays at noon
 - Sign up for a committee or project of interest to you.
 - Visit at least 25 club members at their place of business and secure their signature in your club directory.
 - Serve as a greeter to meet the membership.
 - 5) Once the initiation fee, current period dues are paid, and the photo is received, the sponsoring club member introduces the new member to the club at a regular meeting. A red badge identifying them as a new member is presented to them.

(The whole new member process can take as little as six weeks; longer, depending on the schedules of the sponsoring member and nominee.)
